HUNTINGDON COUNTY COMMONWEALTH OF PENNSYLVANIA

A RESOLUTION OF THE HUNTINGDON COUNTY COMMISSIONERS, COUNTY OF HUNTINGDON, COMMONWEALTH OF PENNSYLVANIA, ADOPTING AN ACTIVE TRANSPORTATION PLAN THAT WILL ENHANCE AND ENABLE SAFE, ACCESSIBLE TRAVEL FOR ALL POPULATIONS AND MODES OF TRANSPORTATION AND WILL GUIDE FUTURE TRANSPORTATION ENHANCEMENT AND INFRASTRUCTURE PROJECTS WITHIN HUNTINGDON COUNTY.

WHEREAS, the Huntingdon County Commissioners have utilized grant funding provided by the Pennsylvania Department of Health through the State Physical Activity and Nutrition grant and Preventive Health and Health Services Block Grant from the Centers for Disease Control and Prevention to prepare an "Active Transportation Plan" for Huntingdon County; and

WHEREAS, the Active Transportation Plan developed in connection with this project demonstrates a commitment by the Huntingdon County Commissioners to enable safe and convenient travel, to provide facilities that support all modes of transportation by serving all potential users including vulnerable and under-served populations, and to improve the health and quality of life of Huntingdon County residents and its commitment to facilitate ongoing and proposed walking and biking enhancement projects in Huntingdon County; and

WHEREAS, the Active Transportation Plan is intended to serve as a guide for decision-making during the planning and design of future transportation enhancement projects, capital improvement projects and other related road infrastructure maintenance projects and initiatives developed and implemented by Huntingdon County and/or its partners; and

WHEREAS, the Active Transportation Plan is intended to ultimately ensure that Huntingdon County's transportation system is planned, designed, operated and maintained to enable safe, convenient and comfortable travel and access for all users and to serve vulnerable and under-served populations within Huntingdon County by requiring itself and Huntingdon County Partners as defined in the Active Transportation Plan to adhere to principles consistent with the Plan and its vision for enhanced access and facilities for all populations of users and modes of transportation;

NOW, THEREFORE, WITH THE FOREGOING RECITALS BEING INCORPORATED HEREIN BY REFERENCE THERETO, THE HUNTINGDON COUNTY COMMISSIONERS HEREBY RESOLVES AS FOLLOWS:

- 1. THAT the "Huntingdon County Active Transportation Plan" (the "Plan") be and is hereby ADOPTED and APPROVED;
- 2. THAT the Huntingdon County Active Transportation Committee be and are hereby authorized to advise the Huntingdon County Commissioners to take actions necessary to implement and enforce the Plan and carry out the purpose and intent of the Active Transportation Plan and this Resolution.

THIS RESOLUTION IS APPROVED AND ADOPTED AT A DULY ADVERTISED MEETING OF THE HUNTINGDON COUNTY COMMISSIONERS HELD THE 17⁺⁰ DAY OF SEPTEMBER 2023 AND SHALL BE EFFECTIVE IMMEDIATELY UPON APPROVAL OF THE AFORESAID HUNTINGDON COUNTY ACTIVE TRANSPORTATION PLAN BY THE HUNTINGDON COUNTY COMMISSIONERS, HUNTINGDON COUNTY, PENNSYLVANIA.
