The properties will be sold at not less than the Upset Prices hereinafter stated for the purpose of compliance with the Real Estate Tax Sale Law of 1947 and its amendments, to obtain the delinquent taxes, costs and expenses due to the various taxing districts.

All prospective bidders must register in person with the Huntingdon County Tax Claim Bureau at 233 Penn Street Huntingdon PA beginning August 12, 2024, through August 30, 2024. This registration requires a photo I.D. such as a valid driver's license or other form of identification acceptable to the Tax Claim Bureau. You must be present to bid. Bids may not be assigned.

No sale of property will be consumated unless a bid is received equal to or greater than the Upset Price.

The sale of any property may, at the option of the Tax Claim Bureau, be stayed if the owner thereof, or any lien creditor of the owner enters into an agreement with the Bureau to pay the taxes in installments in the manner provided by the Real Estate Tax Sale Law and makes such payments as are required and agreed upon. Any such agreement must be made before the date of sale.

The Real Estate Tax Law provides that: "There shall be no period of redemption after such sale and the sale shall be deemed to pass a good and valid title to the purchaser."

Every such sale shall convey title to the property under and subject to the lien of record.

CONDITIONS OF SALE

The property so struck down will be settled before the above next property is offered for sale. Payments must be in the form of a check drawn on a local bank or other acceptable to the Tax Claim Bureau. Deeds for the premises will be prepared by the Tax Claim Bureau and recorded. The Recorder of Deeds will mail the deeds to the address given by the buyer at the sale after the deed has been properly recorded and indexed. In that regard, the buyer must provide to the Recorder of Deeds a self-addressed stamped envelope. Buyers will be required to pay in addition to their bid, at the same time the property is struck down to them, the basic sum of \$58.75 for recording the deed, \$20 per parcel UPI fee.

It is strongly urged that prospective purchasers have an examination made of the title of any property in which they may be interested. Every reasonable effort has been made to keep the proceedings free from error. However in every case the Tax Claim Bureau is selling the taxable interest and property is offered for sale by the Tax Claim Bureau without any guarantee or warranty whatever. All sales will be made under these conditions and will be final. No adjustment will be made after the property is struck down.
